

İNGİLTERE ÜNİVERSİTELERİNDE 1965-1984 YILLARI ARASINDA İSLÂMÎ BİLİMLERDE YAPILMIŞ LİSANSÜSTÜ ÇALIŞMALAR

Bir sure önce İngiltere'de bazı üniversite ve kutuphanelerde araştırma yapma fırsatı bulmuştum. İngiltere'deki üniversitelerde İslâmi bilimlerde yapılmış lisansüstü çalışmaları içeren bir kaynak olup olmadığını araştırırken Londra'da SOAS (School of Oriental and African Studies) kütüphanesinde "Index to Theses" adlı 34 ciltlik bir eserle karşılaştım. Bu, İngiltere'deki üniversitelerde yapılmış lisansüstü tezleri çeşitli ana başlıklar altında ele alıp sıralayan bir periyodik idi. Bu eserdeki "Religion", "Philosophy" ve "Theology" bolumlerini taradım, sonuçta aşağıdaki liste ortaya çıktı. Bir fikir vermesi açısından, bu listeyi, ait olduğunu düşündüğüm bilim dallarına tasnif ederek, ülkemizde İslâmi bilimlerde araştırma yapanların dikkatine sunmayı uygun buldum.
